UKRENERGY project

Overview

The UKRENERGY project, in the framework of the Erasmus+ KA2 CBHE program, is aimed at: i) establishing and implementing new Master Courses on “Energy Efficiency, Building Retrofitting and Energy Planning” in Ukrainian Universities; ii) promoting best practices in the terms of educational methodologies and specific knowledge related to the **energy efficiency and sustainability of buildings**.

The present event represents the third coordination meeting, aimed at - for the period April 2024 - March 2025 - assessing the results so far obtained, discussing the current activities, strengthening the teambuilding among the partnership.

Specific sessions will be devoted to the check of the deliverables to achieve in the next project year April 2025 - March 2026, paying attention to the following steps:

- setting-up / updating of didactical laboratories, based on the equipment delivery;
- distribution of teaching material (digitally printed Lecture Notes and Case Studies);
- implementation in practical terms of the first academic year 2025/2026 of the Master Study Programmes in the Ukrainian Universities;
- further development of the dissemination actions;
- undergoing the project results to quality control and monitoring by the appointed external experts.

The meeting, as well as other mobility flows, was foreseen, according to the former plan, to be carried out online or hosted by Ukrainian Institutions. The serious situation occurring in Ukraine since 24th February 2022 has prevented the possibility for the UA HEIs to host events and staff from Member States. In order to exploit the project resources as much as possible, to foster the partnership teambuilding and ensure a most effectiveness to the project coordination, the partnership has organized in presence and hosted by Member States’ Universities the meetings and other mobility flows.

Coordination meeting expected results

- Project Board: report on results achieved so far by the project, with specific reference to curricular development. Future activities planned at least until the end of the project.
- Evaluation Board: monitoring and assessment of the project’s activities and deliverables achieved, period April 2024 – March 2025.
